Conditional Use Permit (CUP 12-16), Development Agreement (DA 06-16) and Tentative Tract Map (TTM 37145) to establish a new medical marijuana cultivation complex located on the east side of Little Morongo Road, approximately one-half mile north of Dillon Road (northeast corner of Little Morongo Road and 16th Avenue, unimproved) within the General Plan Light Industrial (I-L) Zone.
