Section 2. The City Council hereby authorizes and directs Staff to apply for funding.

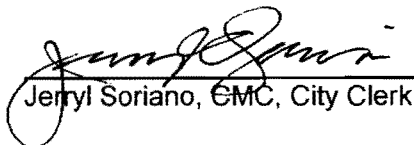
