CALL TO ORDER

The Meeting was called to order at 2:00 PM by Vice-Chair Lennon-Roth.

ADMINISTRATIVE CALENDAR:

1. A recommendation to the Planning Commission for architectural and landscape approval for CUP 2-15 for approximately 180,900 square foot medical marijuana cultivation facility located on Little Morongo Road at Kranshire Boulevard in the I-L (Light Industrial) Zone. Request submitted by David Snider.

Acting Community Development Director presented the project to the Committee and a discussion ensued.

A motion was made by Vice Chair Lennon-Roth and Seconded by Commissioner Kelley with a Vote of 2-0 that the the ALRC recommend that the Planning Commission and City Council approve Conditional Use Permit 2-15 subject to that all practical options to the flooring be explored by the Chief Building Official and if none are found that a solid concrete foundation be required, that all driveways be paved with asphalt or concrete, and chain link fencing be permissible in areas no visible to the public.

2. A recommendation to the Planning Commission and City Council for an Amendment to the Skyborne Specific Plan including Mid-Century/Contemporary architecture as an additional theme and enhanced landscape treatments for the development of active adult communities. Request submitted by James Kozak.
