The meeting was called to order at 2:00 PM by Chairman Ray Lopez.

Chairman Lopez, Vice-Chair Linda Lennon-Roth were present and Committee Member Stephan Mundwiler was absent after a roll call vote.

#### **ADMINISTRATIVE CALENDAR:**

1. Conditional Use Permit No. 04-16. A recommendation to the Planning Commission and City Council for the approval of the design elements of a Conditional Use Permit to establish a medical marijuana cultivation facility within a new 40,440 square foot one-story building on a vacant 2.52 acre parcel. Other proposed improvements include on-site parking and circulation, trash enclosure, retention basin and landscaping. The project is located at southwest corner of San Jacinto Lane and Cabot Road within the General Plan Light Industrial (I-L) Zone. Applicant: Black Pepper Ventures / Chris Jones

A motion was made by Vice Chair Lennon-Roth and Seconded by Chair Lopez with a Vote of 2-0 that the the ALRC recommend that the Planning Commission and City Council approve Conditional Use Permit 4-16 subject to relocation of the Washingtonia Robusta away from the curb, provision of mounding on the perimeter of the site, and more articulation of the street frontage of the building.
