CALL TO ORDER

The meeting was called to order at 10:05 AM by Chairman Ray Lopez

MINUTES

January 8, 2015 Minutes

A motion was made by Vice Chair Lennon-Roth, Seconded by Committee Member Kelly with a Vote of 3-0 that the ALRC approve the January 8, 2015 Minutes.

ADMINISTRATIVE CALENDAR:

1. A recommendation to the Planning Commission for the architecture and landscaping for a 70 foot tall cell tower communication facility designed as a decorative Mission Style Tower on the campus of the Mission Springs Water

District located at 66575 Second Street between Palm Drive and Ocotillo Drive in the MXD (Mixed Use Core) of the Vortex Specific Plan.

Recommendation: That the Architectural & Landscape Review Committee (ALRC) recommends that the Planning Commission approve Conditional Use Permit No. 03-14 for a 70 foot cell facility disguised as a decorative Mission Style Tower on the campus of the Mission Springs Water District located at 66575 Second Street between Palm Drive and Ocotillo Drive.

Rich Malacoff presented the staff report and a discussion ensued. The Commission discussed landscaping, and recommended the following be included in the motion:

- 1. There should be open eaves with exposed beams at the top of the structure.
- 2. All cornice and design details below 10 feet shall be masonry block, wood, or metal.
- 3. If possible make it a clock tower.
- 4. Change staff's recommendation of Desert Museum Palo Verde to a Mexican Palo Verde.
- 5. Concur with staff's recommendation to have the gate and cap of the wall match the roof.
- 6. Color of structure should match the color of the MSWD Building.

A motion was made by Vice Chair Lennon-Roth, Seconded by Committee Member Kelley with a Vote of 3-0 that the ALRC recommend that the Planning Commission approve Conditional Use Permit 3-14 subject to the above recommendations.
