ADMINISTRATIVE CALENDAR:

 Conditional Use Permit No. 9-16. A recommendation to the Planning Commission and City Council for approval of the design elements of a to establish a medical marijuana cultivation facility within a new five building, 102,000 square foot facility on a 7.02 acre parcel located on Little Morongo Road between 18th Avenue and Dillon Road within the L-I (Light Industrial) District. Applicant: Cristiana Gonzales, GFarmaLabs. *Rich Malacoff, AICP, Senior Planner* Recommendation: Staff recommends that the Architectural and Landscape Review Committee (ALRC) recommend that the Planning Commission make a positive recommendation to the City

Rich Malacoff, Senior Planner presented the staff report and recommended the addition of the following:

• Use Desert Museum Palo Verde with Blue Palo Verde

Council

- Fifty percent of the Palo Verde trees shall be 36-inch box and the remaining fifty percent be 48-inch box.
- The Lantana used on site should be both purple and yellow varieties.
- The crushed rock shall be brimstone or dark brown.

The Committee discussed the project and Chair Lopes requested that Staff change the Desert Museum to the Sonoran Palo Verde.

A motion was made by Vice Chair Lennon-Roth and Seconded by Chair Lopez with a Vote of 2-0 that the the ALRC recommend that the Planning Commission and City Council approve Conditional Use Permit 9-16 subject to Staff's recommendation the provision of addition shrubs and mounding along Little Morongo Road.
