

GUIDELINES FOR POLITICAL SIGNS LOCATED IN THE RIGHT-OF-WAY

Initial Here:

Signs shall be located at least one (1) foot behind the edge of a hard surface walk area within the right of way and shall not block or obstruct pedestrian traffic.




I will put all signs at least one (1) foot from the edge of a hard surface walk area; and will not block the sidewalk or pedestrian traffic with an overhanging sign.

Initial Here: _____ When there is no sidewalk present, signs shall be five (5) feet from the edge of the curb or shoulder area to allow for pedestrians and the opening of vehicles.



I will put all signs at least five (5) feet from the edge of a shoulder area in undeveloped areas.



Initial Here: ____ Signs shall be 24" x 18", 432 square inches, or smaller.




The size of all of my signs will be 24" x 18", or 432 square inches, or smaller.




