A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DESERT HOT SPRINGS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, PLACING THE DELINQUENT DESERT VALLEY DISPOSAL BILLINGS ON THE RIVERSIDE COUNTY TAX ROLL FOR FISCAL YEAR 2017-18

WHEREAS; the rates charged by the Desert Valley Disposal, Inc. are established by resolution of the City Council pursuant to Section 8.04.070 of the City of Desert Hot Springs Municipal Code; and;

WHEREAS, the billing, policies, and procedures of Desert Valley Disposal, Inc. are established by the waste disposal agreement between the City of Desert Hot Springs and Desert Valley Disposal, Inc. as further detailed in Resolution No. 2014-008; and

WHEREAS, Government Code Sections 38790.1 authorizes, and Government Code Section 25831 provides procedures for a waste disposal charge to be collected on the tax roll in the same manner, by the same person, and at the same time, together with, not separately from, its general taxes; and

WHEREAS, the City of Desert Hot Springs Municipal Code Section 8.04.040 authorizes placing waste disposal accounts on the Riverside County tax roll; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Desert Hot Springs as follows:

Section 1. The City of Desert Hot Springs hereby elects to have delinquent waste disposal charges as of June 30, 2017, and subsequent Fiscal Years, collected on the tax roll in the same manner, by the same person, and at the same time, together with, not separately from, its general taxes.

Section 2. The City Council hereby finds the collection of delinquent waste disposal charges, together with the general taxes, is in the best interest of the users of the City of Desert Hot Springs.

Section 3. That the cost of delinquent waste disposal charges for each parcel of land shall constitute a special assessment against that parcel of land in accordance with the provisions of the Government Code of the State of California, and pursuant to Section 8.04.040 of the City of Desert Hot Springs Municipal Code.

Section 4. That the assessments, as described in the Desert Valley Disposal Report dated April 7, 2017 and available for public review in the City Clerk's office, are hereby approved for placement on the Fiscal Year 2017-18 Riverside County tax roll utilizing County Fund No. 68-2326

Section 5. The costs against any parcel of land listed in Exhibit "A", assessed by this resolution and the lien created thereby, shall be deemed discharged and released upon the full payment of the property taxes for the tax year above referenced.
