Although I lived in Desert Hot Springs for 6 years, only recently have I become "semi-retired". I have lived in two cities. Desert Hot Springs and predominantly San Diego during this period. I became very familiar with the functions of the commission when I became involved with the ordinances involving fencing and later with the conversion from septic to sewer. I have intended to become involved with City management earlier. Unfortunately, until now, I have been unable since my work schedule prevented involvement.
