Background / Work Experience / Civic Involvement:

I have served as a commissioner on the CCAC in the past and was a director of media and technology for Art Foundation Desert Hot Springs (AFDHS) whose president, Janice Gough, also served on the CCAC. I am currently on the marketing committee for the CREATE Center for the Arts Palm Desert and I work as a freelance social media consultant and content producer.

During my term on the commission, I was involved in the reinstatement of the Holiday Lights and Yard Beautification programs and the completion of the Simi Dabah sculpture installations. Through my work with the AFDHS and the commission, as well as my social media consultancy brownian productions.com, I worked closely with many public artists and commissioners on a variety of projects over the past 3 years. Some of the artists I have worked with include Jorge Sicre, Simi Dabah, Bijan Masoumpanah, Bernard Hoyes, Yudit Escedy, many and others.

It is a personal mission of mine to support and promote the arts and cultural activities in Desert Hot Springs and the surrounding area. I also wish to see our city connect to the global creative community and embrace the multicultural international arts world. I love this city and I am committed to helping it grow and thrive.

Education / Training:

I was homeschooled by my parents, both licensed California educators, and I excelled in the areas of visual arts, music and film production as a child, In 1990, I started attending courses in a variety of arts, media, and technology at City College of San Francisco. My choice of curriculum did not equate to any degree or certification offered at the time but 4 years later it would fit perfectly into the multi-media studies program certification. Unfortunately my credits were not transferable so I never received any kind of certificate.

Being homeschooled with the John Holt "unschooling" methodology, I learned how to learn without the aid of instruction. As such, I have continued to expand my scope of knowledge and develop my skills according to my interests and as necessity occasionally dictates. I am a "quick study" so to speak. In dynamic organizations, I do well and gain the respect of my peers. In mediocre and pedestrian ones, I'm less popular but more motivated to enact change and open my coworkers minds to new possibilities.

I am well acquainted with Chapter 2.44 of the Desert Hot Springs Charter regarding the Community & Cultural Affairs Commission's powers and duties. I am of the opinion that the ordinances relating to the arts, cultural events, historic preservation, community identity, and public relations need to be incorporated into a new branch of the community development department which would have the following functions: A) Review all planning projects using panels of experts in design, architecture, real estate, social services, etc. and offer recommendations. B) Conduct community engagement campaigns that inform the public about development plans and provide an accessible forum for feedback and participation in shaping the city's physical appearance and public amenities. C) Promote the work of artists and the accomplishments of local businesses, organizations, and individuals by holding press events, dedications, honorary events, awards, etc. and publishing a journal of local stories and producing innovative tourism guides and campaigns.							
What specific skills,	attitudes, and experience do you think y	ou have that will enhance t	he work of the Commission?				
I believe in a visionary model of community development. I feel we should embrace the most innovative, progressive, and inclusive movements in the fields of city planning, cultural affairs, social services, housing development, and sustainable economics, incorporating them into our administration's knowledge base and workplace conversation. Advocacy planning, land banking and community land trusts, creative placemaking, etc. Professionally, I have worked mostly in marketing, beginning with an early email marketing startup in Half Moon Bay in 1998. In the post dot-com era I applied my skills to the local music and club scene in San Francisco using self-publishing platforms like MP3.com to help artists grow their own fan bases. Media production and online marketing is a skillset I share with other current commissioners and I believe having more of us with knowledge of technology, promotion, and public relations will make the commission a more savvy and agile presence in the digital world.							

What specific issues or problems face the commission? Do you have suggestions to address these issues or problems?

A) The commission is not connected with people in the community. This is the whole purpose of public arts agencies, which should be a binding and strengthening lattice interwoven throughout and across a community's many layers and sectors. We need to connect with our constituents.

B) The CCAC needs to be supported by a Public Arts Department with at least one staff member with experience/training in public arts admin. We also need to partner with and officially designate a Local Arts Agency to perform some on-the-ground work that the CCAC isn't equipped to handle.

C) The overall arts and cultural community in DHS needs an attractive public image, a brand, that people here can find pride in and people in other communities will be drawn to. The move towards creating an arts district was an excellent idea, but it was not well executed and not followed through. There are enormous resources available for free to communities who wish to develop a cultural district. I continue to insist that we should use these resources and become educated about this subject before proceeding any further.
