FIFTH AMENDMENT TO CONTRACT SERVICES AGREEMENT BY AND BETWEEN THE CITY OF DESERT HOT SPRINGS SUCCESSOR AGENCY AND URBAN FUTURES, INCORPORATED

THIS FIFTH AMENDMENT TO CONTRACT SERVICES AGREEMENT BY AND BETWEEN THE CITY OF DESERT HOT SPRINGS SUCCESSOR AGENCY AND URBAN FUTURES, INCORPORATED ("Fifth Amendment"), is made and entered into as of September 19, 2017 by and between the City of Desert Hot Springs Successor Agency ("Agency"), existing and operating under and pursuant to ABx1 26 and AB1484, and Urban Futures, Incorporated, a California Corporation ("Consultant"), with the Successor Agency and Consultant sometimes together referred to herein as the "parties".

WHEREAS, the Parties previously entered into that certain Contract Services Agreement between the City of Desert Hot Springs Successor Agency and Urban Futures, Incorporated dated March 29, 2012 ("Agreement"), for Consultant to provide the Successor Agency with services related to the implementation of ABx1 26, as amended by AB 1484, and the winding down of the Successor Agency; and

WHEREAS, the Parties previously entered into that certain Amendment to Contract Services Agreement dated April 19, 2014 ("First Amendment"), to expand the scope of services, increase the compensation to be paid Consultant, and extended the Agreement term; and

WHEREAS, the Parties previously entered into that certain Second Amendment to Contract Services Agreement dated August 13, 2014 ("Second Amendment"), to continue and to expand the scope of services, increase the compensation to be paid to Consultant, and further extend the Agreement term; and

WHEREAS, the Parties previously entered that certain Third Amendment to Contract Services Agreement dated July 7, 2015 ("Third Amendment"), to continue and to expand the scope of services, increase the compensation to be paid to Consultant, and further extend the Agreement term; and

WHEREAS, the Parties previously entered that certain Fourth Amendment to Contract Services Agreement dated September 20, 2016 ("Fourth Amendment"), to continue and to expand the scope of services, increase the compensation to be paid to Consultant, and further extend the Agreement term: and

WHEREAS, the Parties desire to again expand the scope of services, increase the compensation to be paid Consultant, and extend the Agreement term.

NOW THEREFORE, in consideration of the foregoing recitals and other food and valuable consideration the receipt and adequacy of which is hereby acknowledged, the Parties hereby agree as follows:
