The City Council approves Staff to participate in the County of Riverside's Urban County Program for Fiscal Year 2018-2019 and authorizes the City Manager to submit the application on behalf of the City. Furthermore, the City Council authorizes the City Manager to approve and execute all agreements, reprograming actions, and make all necessary decisions associated the Program.
