Code Compliance Synopsis

- During the month of January, the Code Compliance /Community Preservation Division completed 75 inspections, and responded to 34 service requests. This resulted in the issuance of 59 notices of violations and 26 citations totaling \$12,700.
- The Community Preservation Division has reached out to retailers and grocery stores within City limits via a letter reminding Management to keep their respected carts upon the store property. The CPD receives many complaints from the public regarding shopping carts littering our streets causing blight and other property maintenance violations.
