9. <u>An Ordinance Amending Chapter 17.180 to Include Special Dispensary</u>
<u>Entitlements in Certain Circumstances</u>

Larry Loren inquired about distributors sending their product out to be tested without a distribution license.

Mark McKinney spoke on behalf of Alan Cooper, the license holder for CUP 14-14, inquired whether the proposed Ordinance would limit or expand their current dispensary license.

Andrew Milks, Brown Dog Dispensary, asked why were non-volatile extraction processes excluded but bakery items were allowed.

Ryan Fingerhut stated his understanding of State and City licensing issues regarding distribution.

Guy Edwards requested that there be clarity regarding a regular dispensary and commercial uses for bakery component.

Mayor Matas closed the Public Hearing.

A discussion ensued.

Action: Betts moved to approve staff recommendation to allow a Special Dispensary Conditional Use Permit for Light Manufacturing in the commercial zone consistent with existing dispensary licenses; that Staff make the change administratively without requiring a separate CUP process; that edits be made to "Item 5 - Off-Site Marijuana" Sales" to add language regarding marijuana products versus regular merchandize products; and adding an Item 7 regarding odor control, motion seconded by McKee, motion carried 5/0 by the following vote:
