We recommend replacing the older DE filters and older heaters. The existing DE filters will be replaced with new commercial sand filters with glass media. This will reduce annual operating costs by more than \$1,000 per filter. The 10 year old heaters will be replaced with new as well. We are providing specifics for your review, detailed below.

- 1) Removal of the existing filters and installation of (2) new commercial sand filters with glass media. Includes all labor and materials and are accompanied by a (10) year limited manufacturer's warranty.
