Subject: Countywide Oversight Board for the County of Riverside - Information on First Meeting

Pursuant to Health and Safety Code Section 34179 (j), effective July 1, 2018, the Countywide Oversight Board for the County of Riverside (Countywide Oversight Board) shall be in operation and the current Oversight Boards of all Successor Agencies within the County of Riverside shall dissolve.

The Countywide Oversight Board will be governed by a seven (7) member board, appointed in accordance with Health and Safety Code Section 34179 (j), and will have jurisdiction over twenty-five (25) Successor Agencies associated with the following cities and joint power authority:
