A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DESERT HOT SPRINGS, CALIFORNIA, ASSIGNING THE CITY MANAGER AS AUTHORIZED AGENT FOR THE PURPOSE OF OBTAINING FEDERAL FINANCIAL ASSISTANCE PROVIDED BY THE FEDERAL DEPARTMENT OF HOMELAND SECURITY

WHEREAS, the City of Desert Hot Springs has been awarded, for the performance period of October 21, 2019 through May 31, 2021, a grant of \$4,266.00 from the federal Department of Homeland Security for the support of Community Emergency Response Teams (CERT) project training,

WHEREAS, the City of Desert Hot Springs has elected to continue the CERT project providing the minimum training standard as community based first responders for local residents, administered by the Desert Hot Springs Fire Department using the grant funds to directly pay for CERT materials and instructors,

WHEREAS, the Department of Homeland Security grant of \$4,266.00 requires a resolution of the governing body of the City of Desert Hot Springs assigning an authorized agent to execute for, and on behalf of, the named applicant, a public entity established under the laws of the State of California, any actions necessary for the purpose of obtaining federal financial assistance provided by the federal Department of Homeland Security and sub-granted through the State of California,

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED BY THE CITY COUNCIL FOR THE CITY OF DESERT HOT SPRINGS, AS FOLLOWS:

Section 1. RECITALS

That the recitals set forth above are true and correct and are hereby incorporated herein as findings of the City Council.

Section 2. FINDINGS

That the City Manager, or his designee, is the Named Authorized Agent for the purpose of obtaining federal financial assistance provided by the federal Department of Homeland Security and sub-granted through the State of California.

Section 3. CITY MANAGER'S AUTHORITY

That the City Manager, or his designee, are hereby authorized to take any and all actions and to execute all documents, which may be necessary to implement and administer the purposes set forth in this resolution.

Section 4. EFFECTIVE DATE

That this resolution shall take effect immediately upon its adoption.

Section 5. CERTIFICATION

That the City Clerk shall certify to the passage and adoption of this resolution, enter the same in the book of original resolutions of the City and make a minute of passage and adoption thereof in the records of the proceedings of the City Council in the minutes of the meeting at which the same is passed and adopted.

Section 6.

SEVERABILITY

That if any provision of this resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this resolution which can be given effect without the invalid provision or application, and to this end the provisions of this resolution are severable and that the City Council hereby declares that it would have adopted this resolution irrespective of the invalidity of any particular portion thereof.
