The Undersigned hereby declares:

(a) That the only persons or parties interested in this proposal as principals are the following:

It is understood and agreed that the quantities set forth are but estimates, and that the unit prices will apply to the actual quantities whatever they may be.

Accompanying this bid proposal is a certified or cashier's check or bidder's bond, payable to the order of the City of Desert Hot Springs in the sum of One Hundred Seventy Four Thousand Nine Hundred Eighty Nine and 00/100 DOLLARS (\$ 174,989.00 ) Said bidder's bond has been duly executed by the undersigned bidder and by a financially sound surety company authorized to transact business in this state.


