

RESOLUTION NO. 2019-_____

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DESERT HOT SPRINGS APPOINTING A QUALIFIED INDIVIDUAL TO FILL THE CITY COUNCIL VACANCY CREATED BY THE RESIGNATION OF COUNCIL MEMBER ANAYELI ZAVALA, EFFECTIVE UPON VACATION OF THE SEAT

WHEREAS, Council Member Anayeli Zavala will resign from the Desert Hot Springs City Council effective July 2, 2019; and

WHEREAS, at a Regular City Council Meeting on May 21, 2019, the City Council adopted Resolution No. 2019-019 electing to appoint a qualified individual to fulfill the remainder of the term of the vacated office which office ends December 2020 in accordance with Government Code Section 36512; and

WHEREAS, at a Special City Council Meeting on June 25, 2019, the City Council appointed a qualified individual to serve the remainder of said term effective upon vacation of the seat.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Desert Hot Springs as follows:

Section 1. RECITALS

That the recitals set forth above are true and correct and are hereby incorporated herein as findings of the City Council.

Section 2. APPOINTMENT TO FILL CITY COUNCIL VACANCY

That pursuant to Government Code Section 36512, _____ is appointed as a member of the City Council effective upon vacation of the seat, and shall serve for the remainder of the unexpired term of the former incumbent, Anayeli Zavala.

Section 3. OATH OF OFFICE

That the person appointed shall receive the Oath and take office on July 2, 2019, and serve exactly as if elected at a municipal election for the office.

Section 4. EFFECTIVE DATE

That this resolution shall become effective immediately upon its adoption.

Section 5. CERTIFICATION

That the City Clerk shall certify to the passage and adoption of this resolution, enter the same in the book of original resolutions of the City and make a minute of passage and adoption thereof in the records of the proceedings of the City Council in the minutes of the meeting at which the same is passed and adopted.

Section 6. SEVERABILITY

That if any provision of this resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect the other provisions or applications of this resolutions which can be given effect without the invalid provision or application, and to this

end the provisions of this resolution are severable and that the City Council hereby declares that it would have adopted this resolution irrespective of the invalidity of any particular portion thereof.
