Oversight of more than 80 task force officers representing 23 different law enforcement agencies (local, state and federal). Completion of bi-annual reports to the Executive Board (chief executives of all enforcement agencies in Riverside County) were required. A complete re-write of the Task Force's Policy and Procedure's Manual was completed and approved by the Board. Oversight of RSO personnel assigned to the SAFE Task Force (16 staff members) and preparation of budgets for both units was also required.

Sheriff's Captain – Larry D. Smith Corr. Facility Duties: Supervision of all Facility functions and personnel while ensuring that the Facility complied with all Title 15 and 24 requirements. Preparation of the facility for incorporation of the new 582 bed expansion project. Oversight of the Secure Electronic Confinement Program, Work Release Program and the SITE-B/RSAT Program.

I implemented the Zone Policing Strategy at Indio Station in April of 2005, more than one year prior to other patrol stations (other then Jurupa Valley) implementing similar strategies. Rebuilt and strengthened the station's relationship with the neighboring law enforcement agencies, the local Native American nations and the Palm Desert Station. Developed and implemented the floor plans for the new Mecca Sub-Station and new Thermal Station.

March 2003 - Jan. 2005

Sheriff's Lieutenant / Assistant Chief of Police - Cabazon Station

Duties: Supervision of the station's Administration, Patrol. Investigations and Evidence sections and the contract city operations for the city of Calimesa. This assignment included the preparation of department budgets for the Cabazon Station sub-org and police department budgets for the contract city. During this assignment, I was assigned as the Assistant Chief of Police for the city of Calimesa. I also served as the department liaison to the Morongo Tribe for the building and opening of the new 27-story Morongo Casino resort and hotel. I also developed and implemented a full evacuation plan for the city of Calimesa in the event of a major wildfire. An additional assignment included the development of the strategy for the creation and implementation of the Felony Warrant and Extradition Team (FWET). Additional duties included Acting Station Commander and member of the Department's Disaster Response Team

Jan. 2001 - March 2003

Sheriff's Lieutenant / Assistant Chief of Police - Indio Station

Duties: Supervision of the station's Administration section and the contract city operations for the cities of Coachella and La Quinta. I served as the Assistant Chief of Police for the cities of Coachella and La Quinta. This assignment included the preparation of department budgets for the Indio Station and Forensics-East sub-orgs and police department budgets for the two contract cities. During this assignment, I was assigned to and completed a complete remodel of the station's interior. I was also assigned to develop the strategy for the creation and implementation of the first gang task force in the County of Riverside. This strategy was later used in the creation and implementation of the county-wide gang task forces. Additional duties included Acting Station Commander, oversight of the Forensics-East unit, supervision of the Special Enforcement and Traffic teams for the contract cities and member of the Department's Disaster Response Team.

Jan. 1998 - Jan. 2001

Sheriff's Sergeant – Riverside/Jurupa Valley Station Duties: Patrol Watch Commander with later assignment as the Zone 1 Community Action Team supervisor (COP program). This assignment involved the implementation of the first complete Community Oriented Policing program in the Department.

Sheriff's Investigator – SIB East & West Duties: Investigation of criminal activity including narcotics and vice offenses (specializing in clandestine drug laboratory investigations). Duties included participation in undercover positions. This assignment also included a special two year deployment to the DEA Clan Lab Task Force and the oversight of major Federal investigations throughout the United States. During this assignment, I was recognized for achieving the first successful Federal jury trial prosecution of defendants charged with the transportation and distribution of precursor chemicals.
