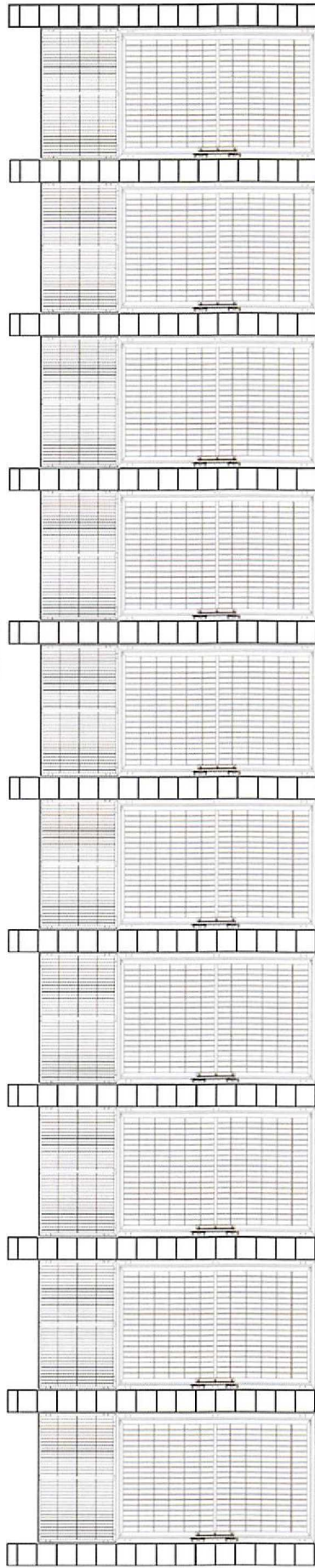
Flag panel above block Wall



Outside Elevation



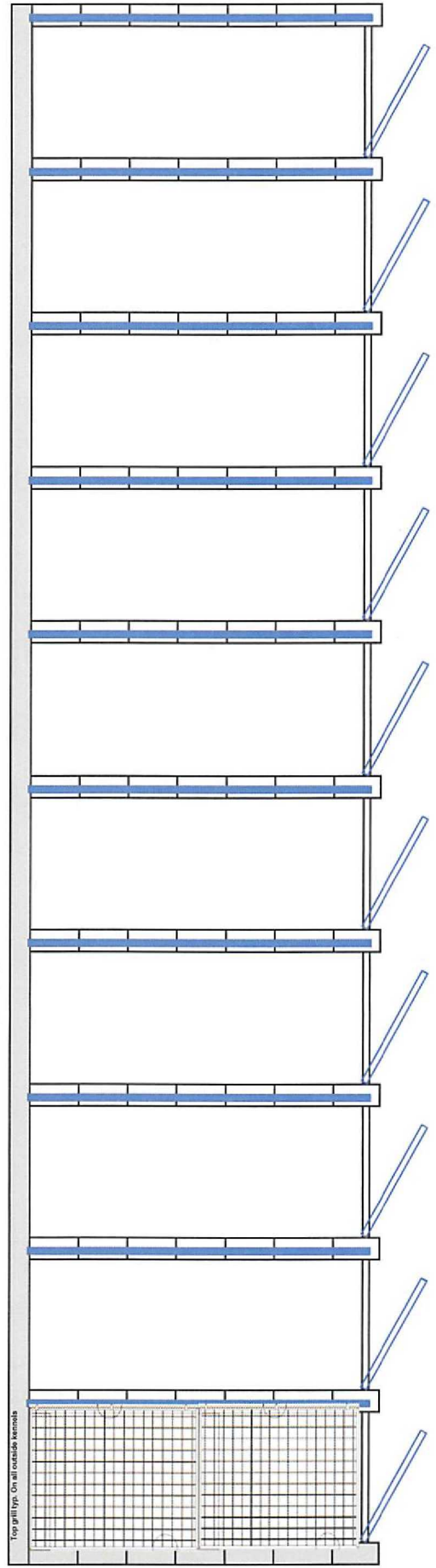
Inside Elevation

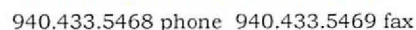

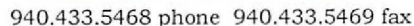
