Re: AMENDED & RESTATED FY 2020-21 SOLID WASTE ASSESSMENT ANNUAL REPORT

This AMENDED and RESTATED FY 2020-21 SOLID WASTE ASSESSMENT ANNUAL REPORT supersedes that Report submitted April 1, 2020. The delayed release of vendor pricing after our original submittal necessitates this amendment.

This is the '**2020-21 Solid Waste Assessment Annual Report**' for amounts levied on the County of Riverside property tax bill for single-family residential dwellings in the City of Desert Hot Springs receiving individual weekly solid waste collection and not billed directly by Desert Valley Disposal.

This Annual Report is prepared pursuant to Sections 5470, et seq. of the California Health and Safety Code and Sections 41900 et seq. of the California Public Resources Code for the annual levy and collection of assessments against developed parcels within the City of Desert Hot Springs for solid waste management services for the fiscal period commencing July 1, 2020 and ending June 30, 2021. The electronic listing accompanying this Annual Report, and by this reference made a part hereof, includes a description of each property, the amount of the levy for each property and other applicable information. *(In order to account for last minute additions or deletions, the electronic listing (EXHIBIT 3) will be provided on June 2, 2020.)*

1. AUTHORITY

Desert Hot Springs Municipal Code Section 8.04.040 authorizes the collection of fees and charges for solid waste service on the property tax bill.

2. SERVICE AREA

The Service Area consists of the seven thousand three hundred seventy (7,370) properties subject to the charges which constitute all parcels within the territorial limits of the City of Desert Hot Springs developed as single-family residential premises that are provided individual solid waste collection and that are not billed directly for that service by the City's authorized contractor. Reference is hereby made to the County of Riverside Assessor's Rolls for the location and detailed description of each parcel.

3. NECESSITY FOR CHARGES

Desert Hot Springs Municipal Code Section 8.04.040 requires every person who owns, and every person who occupies, any developed real property to arrange and pay for solid waste collection services. Pursuant to Municipal Code Section 8.04.400, the City Council has entered into an agreement with a contractor (Desert Valley Disposal, Inc.) to provide these services that include the collection of refuse and recyclable materials. Said agreement further provides for the collection of fees and charges on the County property tax bill for solid waste services rendered to parcels developed as single family dwellings.

4. COST OF SERVICES

For Fiscal Year 2020-21, the total amount of the levy for the properties subject to levy is \$2,519,280.25, which includes the cost of solid waste management services, \$2,511,696.00, and the City's cost of administering the placement and collection of the levy, \$7,584.25.

The assessment for individual properties is \$341.83. The charges for solid waste services are set forth in our Rate Schedule Effective July 1, 2020 included herewith as EXHIBIT 1. (Note: The Rate Schedule effective July 1, 2020 is scheduled for consideration and approval by the City Council the April 21, 2020 regular meeting.)

The City's administration costs are described in EXHIBIT 2.

Table 1 summarizes the FY 2020-21 Total Tax Levy and Individual Assessment.

5. ELECTRONIC ACCOUNT LISTING

The electronic listing of Desert Hot Springs tax roll accounts within the Service Area are to be placed on the Fixed Charge Tax Roll, for fund number 68-1500. Should you receive "Kick-Off" lists from the Riverside County Assessor, please forward them to us immediately so that we can research and resubmit any questioned accounts.

6. CONSIDERATION BY THE CITY COUNCIL

This matter is scheduled to be presented to the City Council at its regular meeting on April 21, 2020 for consideration of a resolution of intention and to set the time and place for a public hearing and again on June 2, 2020 at which time the public hearing will be held.

The City Clerk shall cause the Notice of Public Hearing to be published and posted in advance of the June 2, 2020 meeting as required by Statute.

7. DISTRIBUTION OF FUNDS

The County of Riverside Auditor/Controller typically distributes tax levy collections to the City in four (4) payments in January, May, August and October. Per the terms of the Franchise Agreement, the City will in turn disburse the levy proceeds to Desert Valley Disposal (DVD) within fourteen (14) days of receipt of distributions from the County.

When disbursing funds to DVD, the City is to withhold fees due to City for tax levy Administration costs at the rate of 0.3013% and for Franchise Fees at the rate of 10.8826%. Table 2 sets forth these withholding percentages for the 2020-21 disbursements.

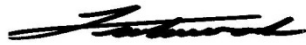

When computing the withholding amounts for the City Tax Levy Administration Fee and the City Franchise Fee from the disbursement to DVD, the City is to apply both of the above percentages to the total disbursement received by the City from the County.

The City Waste Diversion Fee is not withheld at the time of disbursement. Instead, DVD pays that fee quarterly based upon actual tonnage delivered for disposal.

Re: AMENDED & RESTATED 2020 RATE ADJUSTMENT NOTICE

This AMENDED and RESTATED Rate Adjustment Notice supersedes that Notice submitted March 30, 2020. The delayed release of vendor pricing after our original submittal necessitates this amendment.

This is our 2020 Rate Adjustment Notice. The proposed rates for solid waste services are presented in the attached Franchise Agreement Attachment F Rate Schedule (Exhibit 1).

The rate adjustment, effective July 1, 2020, accounts for the annual CPI formula adjustment and for increases in tip fees charged by facility operators that dispose or divert waste.

CPI FORMULA ADJUSTMENT

The change in the Consumer Price Index, Los Angeles Area, All Urban Consumers (CPI-U), February to is +3.36%.¹ The Service Fee component of the rate structure will be adjusted by that amount.

FACILITY TIP FEE INCREASES

The change in the Tip Fee rate component accounts for changes in the various tip fees charged by facility operators.

Disposed Waste

Solid waste collected by DVD for disposal is delivered to the Edom Hill Transfer Station ("EHTS") for disposal in the County of Riverside waste management system.

The tip fees charged at the facility are adjusted annually each July 1st according to the terms of the operating agreement between the County and the EHTS operator.

The facility operator has announced that the disposal tip fee will increase 3.61% from \$48.97 to \$50.74 per ton effective July 1, 2020. (Refer to Exhibit 2).

Last year the facility operator quoted a tip fee of \$49.03 but in August revised the price to \$48.97 per ton after the County unexpectedly changed the inflation index used to compute the landfill tip fee. Inasmuch as our 2019 rates were set based on \$49.03 per ton instead of \$48.97, this year we are crediting back the \$0.06 in the 2020 rate. (Refer to Exhibit 4.)

Green Waste

Green waste collected from customers in Desert Hot Springs is delivered to the Edom Hill facility for processing into beneficial mulch.

The green waste facility operator has announced that the green waste tip fee will increase 9.10% from \$48.00 to \$52.37 per ton effective July 1, 2020 (Exhibit 2).

The green waste tip fee is included in the 'Tip Fee' component of the rate for Residential customers. For Commercial premises, the green waste tip fee is billed as a distinctly separate service.

Mixed Recyclables

Mixed recyclables collected by DVD from Residential and Commercial premises are delivered to the EHTS for transfer to an offsite processing facility before being shipped to market for recycling.

The cost for this tip fee is accounted for in the 'Tip Fee' component of the rates for Residential and Commercial premises.

The facility operator has announced that the tip fee for mixed recyclables will increase 12.17% from \$81.70 to \$91.64 per ton (Exhibit 2).

The mixed recycling tip fee is included in the 'Tip Fee' component of the rate for Residential and Commercial customers.

Food Waste

Food waste and food waste mixed with other organic waste, when collected by DVD from Commercial premises, will be delivered to the Coachella Valley Compost for processing into a beneficial mulch product.

For Commercial premises, the food waste tip fee is billed as distinctly separate service.

The facility operator has announced that the tip fee for food waste will increase 7.69% from \$65.00 to \$70.00 per ton (Exhibit 2).

Construction Waste

Construction waste generated in the City is delivered to Desert Recycling in Thousand Palms for processing and recovery.

When construction waste is collected in debris boxes, the facility tip fees are charged to the customer at the face amount.

The current rates became effective January 1, 2020 and are described in the operator's price list is attached as Exhibit 3.

RATE ADJUSTMENTS FOR TIP FEE CHANGES

Exhibit 4 describes the change to Tip Fee rate components for the various sectors and services.

Residential Tip Fee Adjustment

The Tip Fee component of the rates for Residential sector services (including Commercial carts/cans) will increase 5.94%.

Commercial Tip Fee Adjustment

Tip Fee component of the rates for Commercial sector services will increase as follows:

- Disposed Waste +4.55%;
- Green Waste +9.10%;
- Food Waste & Mixed Organic Waste +7.69%;

Roll-Off Tip Fee Adjustments

Tip Fees for Industrial sector services will be adjusted as follows:

• Disposed waste	+3.49%	\$50.74/ton
• Green waste	+9.10%	\$52.37/ton
• Concrete/asphalt	-43.75%	\$9.00/ton
• Sod/dirt	+40.00%	\$35.00/ton
• Mixed construction	+26.67%	\$95.00/ton
• Sweeper sand	+11.11%	\$50.00/ton
• Clean lumber	+9.38%	\$35.00/ton
• Clay/ceramic tile	+20.00%	\$30.00/ton
• Gypsum	+20.00%	\$60.00/ton

Diversion tip fees are passed through to roll-off customers at the rate in effect at the time that service is rendered.

NEW OR CHANGED SERVICES

We have added some new services for our customers and changed others.

Cannabis Waste Documentation Service

The Cannabis Documentation Service is being reinstated to assist cannabis industry customers in complying with tracking and reporting requirements.

Extra Recycling Cart

The option of arranging for additional recycling carts for a fee will be available to Residential customers.

Commercial Bulky Item Pick-Up

Commercial customers will be offered the ability to arrange for bulky item pick-up at reasonable fees.

Residential Bulky Item Pick-Up

Residents already receive FREE collection of 6 Bulky Items per year. The cost for additional Bulky Items is being reduced to encourage proper disposal of bulky items.

Construction Waste

The time required to transport debris boxes containing construction waste to the diversion facility in Thousand Palms is adversely impacting the productivity of the collection vehicles. We have increased the pull charge for debris box loads of construction waste to offset the added time required. The rates for diverting green waste are not impacted by this change.

Debris Box Weight Limits

We have increased the maximum acceptable weight limits for debris box and stationary compactor loads from 8-tons to 10-tons. This change will benefit customers without the gross vehicle weights exceeding legal limits.

CITY FEE REVENUE

Rate components for City Fees will increase by 3.36%. We estimate that these fees will generate approximately \$1,040,000 in FY'20-21 (before adjustment or decreases in business due to the COVID-19 crisis).

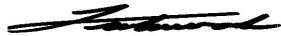

- (4) Disposal Fee will be added at the time of service based upon the processor's fee in effect when service is rendered for the materials generated & based upon the following density factors per cubic yard): wood scrap (330 lbs), metal scrap (960 lbs), sheetrock scrap (394 lbs), concrete (1,855 lbs), asphalt composition shingles (419 lbs), asphalt paving (1,380 lbs) and other materials as determined by Contractor.
- (5) The Disposal Tip Fee is subject to change simultaneous with changes in the processing tip fee levied by the facility operator.

Dear Mr. Wade,

Please accept this letter as notification of rate increases for refuse, green waste, food waste, and recycling transportation and processing. The new rates will be effective July 1, 2020 and are as follows; refuse \$50.74/ton (rate subject to change based upon our request of the County for an additional extraordinary cost adjustment to comply with new AQMD requirements), green waste \$52.37/ton at Edom Hill. Food waste at Coachella Valley Compost will be \$70.00/ton.

China's National Sword eliminated the import of 24 types of recyclable materials including mixed paper and plastics. China was the world's largest importer of these materials consuming over 50% of the market. This action has negatively changed the dynamics of the recycling industry for the foreseeable future and has caused Material Recovery Facilities to try and find other nations to take the China banned materials. This has created an imbalance in the supply and demand of the materials which has caused the value of the material to plummet. China also implemented strict contamination guidelines of .05% for the materials they will accept. Contamination levels of .05% is very difficult, if not impossible, to achieve with current processing technology. Other nations have also followed China's contamination restriction standards.

Material Recovery Facilities have been forced to slow processing lines down and add manpower to the sorting lines to meet the strict contamination guidelines. As a result, the cost of processing recyclable materials has significantly increased while the value of the material has been significantly reduced.

The change in the recycling industry has compelled Material Recovery Facilities to raise processing fees and reduce material value. Your current fee to load, transfer and process the recyclable materials is \$81.70/ton. As a result of the continued recycling changes outlined above, the new fee will be \$91.64/ton.
