### RESOLUTION NO. 2020-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DESERT HOT SPRINGS, COUNTY OF RIVERSIDE, STATE OF CALIFORNIA, ADOPTING THE USERS FEE STUDY PREPARED BY REVENUE AND COST SPECIALISTS, LLC, DATED APRIL 2020

**WHEREAS**, the City of Desert Hot Springs has conducted an analysis of its services, the costs reasonably bone from providing those services, the beneficiaries of those services, and the revenue produced by those paying fees and charges for special services; and

**WHEREAS**, the City wishes to comply with both the letter and the spirit of Article XIIIB of the California Constitution and limit the growth of taxes; and

**WHEREAS**, the City provides various planning and building development services to the public including, but not limited to, processing applications, reviewing plans and maps, issuing permits and reviewing development agreements (the "Building and Planning Services"); and

WHEREAS, the City desires to establish a methodology of recovering some portion of the costs reasonably borne from providing certain other special services, including but not limited to, those concerning park and recreation services, rental of City property, police and fire services, and other miscellaneous City services, of a voluntary or limited nature, such that general taxes are not diverted from general services of a broad nature and thereby utilized unfairly and inequitably for such special services ("City Services"); and

**WHEREAS**, City Council intends to collect various fees (the "Fees") and, in certain cases, require advance deposit of the Fees, to offset the costs associated with providing the Building and Planning Services and City Services; and

**WHEREAS**, because some of the Fees are described in Government Code Section 66014, the City is required o hold at least one open and public meeting as well as a general description of the matter to be considered are to be mailed at least 14 days prior to the date of the meeting to those parties (if any) who have filed requests for such notifications; and

**WHEREAS**, since no requests for such notification were filed with the City, no notices were mailed; and

**WHEREAS**, data indicating the amount of the estimated cost required to provide the Building and Planning Services and City Services and the resources anticipated to fund the same were made available to the public at least 10 days prior to the date of this meeting, in accordance with Government Code Section 66016; and

WHEREAS, pursuant to Government Code Sections 66016 and 66018, the enactment or increase in any fees to be charged for services must be adopted by the City Council by ordinance or resolution, after providing notice and holding a public hearing; and

**WHEREAS**, pursuant to Government Code Section 66018, the City complied with all notice and hearing requirements thereof; and

WHEREAS, Revenue & Costs Specialists, LLC, has prepared and presented to the City Council a "User Fee Study Update for the City of Desert Hot Springs," dated April 2020 (the "User Fee Study"), a copy of which is attached hereto and incorporated herein by this reference as Exhibit "A", which details the amount of cost, or estimated cost, required to provide the service for which the fee or service charge is levied and the revenue sources anticipated to provide the service, including General Fund revenues, if any; and,

**WHEREAS**, a duly noticed public hearing before the City Council was held on June 16, 2020, at which public testimony was received and duly considered on the proposed Fees; and

**WHEREAS**, the amount of the Fees does not exceed the true cost of providing the Building and Planning Services and City Services; and

WHEREAS, any increase to the amount of the fees as set forth in the User Fee Study is not a "project" subject to the California Environmental Quality Act because it is a funding mechanism have no physical effect on the environment.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Desert Hot Springs as follows:

### Section 1. RECITALS

That the Recitals set forth above are true and correct.

# Section 2. APPROVAL OF USER FEE STUDY

That the City Council hereby approve and adopt the User Fee Study and the fees and charges contained herein.

# Section 3. REPEAL OF CONFLICTING PROVISIONS

That all the provisions heretofore adopted by the City Council that are in conflict with the provisions of this Resolution are hereby repealed.

#### Section 4. SEVERABLITY

That if any provisions of this Resolution or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the invalid provision or application, and to this end the provisions of this Resolution are severable. The City Council hereby declares that it would have adopted this Resolution irrespective of the invalidity of any particular portion thereof.

#### Section 5. EFFECTIVE DATE

That this Resolution shall take effect upon its adoption and the User Fee Study and the Fees contained therein shall take effect immediately.

# Section 6. CERTIFICATION

That the City Clerk shall certify to the passage of this Resolution and enter it into the book or original resolutions.
