**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
DESERT HOT SPRINGS, COUNTY OF RIVERSIDE, STATE
OF CALIFORNIA, ESTABLISHING THE CITY'S
APPROPRIATIONS LIMITATION FOR FISCAL YEAR 2020-21**

WHEREAS; Section 7900 of the Government Code, added by Chapter 220 of the Statutes of 1980, Division 9, provides for the effective and efficient implementation of Article XIII B of the California Constitution; and

WHEREAS, Section 7910 requires each local government to establish its appropriations limit each year pursuant to Article XIII B of the California Constitution; and

WHEREAS, in 1990, the voters of California adopted Proposition 111 which amended Article XIII B of the California Constitution; and

WHEREAS, Proposition 111 establishes Fiscal Year 1978-79 as the base year for calculating the annual appropriations limit and permits the City to re-establish the annual appropriation limit for all succeeding years based upon growth factors; and

WHEREAS, a resolution establishing the annual appropriations limit is to be adopted at a regularly scheduled meeting of the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Desert Hot Springs as follows:

Section 1. The appropriations limit for fiscal year 2020-21 is hereby set at \$33,861,725, as detailed in Exhibit 2.

Section 2. The City reserves the right to adjust or amend the appropriations limit based upon the use of alternative growth factors as authorized by Proposition 111 if such changes or revisions would result in a more advantageous appropriations limit now or in the future.
