## DISCUSSION

In keeping with the Council direction of that May 12, 2020 be set as the deadline for applications, a review of all applications was made and a list of potential candidates to fill the vacancy on the City Planning Commission was developed. All Council members were provided a copy of that list (below) via email from the City Clerk dated May 12, 2020. The list contains twenty-two (22) applicants who had indicated their interest in serving on the Planning Commission.

Following receipt of the list, Council Member Betts reached out to individuals with technical expertise in city planning and Planning Commission functions and duties and the roles and duties for the purpose of developing a questionnaire, with the questionnaire serving as means by which to screen applicants and gauge their level of knowledge and understanding regarding matters coming before them as a Planning Commissioner. In addition to the expert input, further input was gathered in the development of the questionnaire through a survey of several cities throughout California and where appropriate, to incorporate their methods in the Planning Commission selection process into the questionnaire. The final result of this effort was the development of a questionnaire to be presented to all twenty-two applicants (Exhibit 1).

On June 22, 2020, each applicant was sent a copy of the questionnaire via email to the email address each had provided with their initial application. Further, in an effort to ensure each applicant had received the questionnaire, all twenty-two applicants were called an alerted that an email containing the questionnaire had been sent to them. As it turned out, this was beneficial as several applicants indicated the email had been delivered to their junk mail folder rather than their regular email inbox and without the phone call they would not have been aware of the questionnaire.

The effort to contact all twenty-two applicants by phone was successful either by message delivered to a voice mailbox or live phone conversation. A phone number was left for all applicants should they have questions. A deadline for return of the questionnaire was set for Friday, June 26, 2020 at midnight.

By the deadline, a total of 12 questionnaires had been returned in a timely manner. Those questionnaires have been reviewed and the process to call each of the remaining 12 applicants is now in process but was not able to be completed in time for the posting of the agenda for the July 7, 2020 council meeting. Thus, it is recommended that they City Council continue this item to a date certain of September 1, 2020, that being the next regularly scheduled City Council meeting.
